My Journey by Nancy Burnell

As you know, everyone who has ever had cancer has their own story to tell. They are all different, as is every individual. It is difficult to know where to begin as you share events in your life, but I will start here. I was born in 1948 and blessed with wonderful parents. We were a middle class family, my Dad was a minister and my mom was a supervisor at the telephone company I was brought up in church, started playing the piano at the age of five and asked Jesus into my heart at the age of eight.

The first time I ever heard the word cancer, I was about six years old. In the fifties, it was a big deal to visit someone in the hospital because children were not allowed to enter patient rooms. My paternal grandmother had cervical cancer (surgery and treatments, I cannot recall the type) which meant nothing to me at the time. She was in remission and lived a healthy and active life until she was faced with colon cancer at the age of 77 (she had surgery with a colostomy, but treatments were not recommended. She had waited too long to seek help and passed away two months later.) At around the age of 12, my maternal Grandmother had colon cancer (surgery with a colostomy, which she had the remainder of her life, but

required no treatments.) Being older (and her living with us), I saw the lifetime effect of this cancer and knew it was something I hoped never to face. She lived until the age of 88 cancer free.

In 1969 (age 21), I gave birth to

a precious daughter (with Turner's Syndrome, a genetic disorder) and 12 years later (age33) was blessed with another beautiful and healthy daughter. At the age of 35, I began having very heavy menstrual periods which continued until my late thirties, when they became very irregular. Menopause had begun. My OB/GYN suggested that I consider having a hysterectomy. Finally at the age of 50, I consented.

While recuperating from surgery, I received a call from my Dad informing me he had been diagnosed with colon rectal cancer. He had radiation prior to surgery (to reduce the size of the tumor), a colostomy for life with surgery and chemo followed. During his four and one half year battle with this disease, it had metastasized to his lungs and liver. He passed away in January, 2002. My whole world was turned upside down. I didn't think things could ever be worse, but soon learned that it could. Seven months later, my first born child, (now 33) unexpectedly passed away (August, 2002) from heart and lung complications related to Turner's Syndrome. My world stopped. The death of a child (no matter the age) is the worst thing a parent can go through. I knew life would never be the same. I also never knew a heart could be so broken and one could still survive. For months I was in a daze. Only with my faith in God and the love and understanding of my family and friends was I slowly able to bring life back to my soul.

I was always conscious about my health and went for my yearly physical regularly. In my thirties, I was told I had fibrocystic breasts. They were tender and somewhat painful at times, no lumps, but, my OB/GYN kept a watchful eye on my mammograms for any changes. In my mid forties, I began having cysts from time to time that were removed or aspirated...always benign. Once the cysts started, I began having a mammogram prior to my yearly OB/GYN appointments. My visit in December, 2002 was routine. In December 2003, after examining me, my doctor said to me, he felt no lump in my breast but there was a change in my mammogram. I was sent directly to a surgeon and a biopsy was scheduled the next week. Later in the week, the surgeon called and said the biopsy revealed cancer, but it appeared to be contained. I was very calm, but still grieving for my Dad and Daughter. In my heart I didn't believe I could go through anything else traumatic. I knew at that moment that my strength for this battle would have to come from only one source....God. I remember hanging up the telephone, bowing my head and turning it all over to Him.

At this time of year, the Christmas holidays were upon us and surgery was scheduled for the first week in January. We arrived at the hospital at 5:00 a.m. and went, into surgery at 6:30 a.m. The surgery lasted approximately six hours because I elected to have TRAM reconstruction after the mastectomy. My surgeon, during the course of the surgery removed a clump of six lymph nodes, sent them to the lab....they all tested negative for cancer. In his wisdom, (and God's guidance) he decided to remove another small clump of five lymph nodes that were close in proximity to the first six. This was a life changing decision, for this batch had one positive lymph node. This was a huge revelation for my cancer and the course of treatment, it was now stage II instead of I. It was not contained as first believed and was very aggressive. It was identified as Triple Negative, Infiltrating Ductal Carcinoma (not good). My BRACA1 and BRACA 2 test results were negative (good).

Three weeks after surgery, I began chemotherapy. No radiation was required. Six months after completing chemo, I was introduced to Steel Magnolias breast Cancer Support Group (and Men of Steel). What a blessing it has been for me to be involved in this wonderful group of Christian women and men. We are all in the same sorority (that of breast cancer or its effect), certainly not by choice, but each needing love, support, understanding and a greater knowledge of this disease in order to help others who will be affected.

In closing....,two years ago, I lost my Mother to COPD and Husband to Glioblastoma (six months apart). I now am very involved in my church (where I play the organ), community affairs and of course Steel Magnolias (where I have been honored to serve as Treasurer and on its Board).

If I could describe my life in one word, it would be BLESSED. Blessed that I had wonderful Christian parents who taught me right from wrong, blessed by grandparents who led by their example, blessed that I was married to my soul mate and best friend, blessed that I had 33 years with my oldest daughter before her passing, blessed that my younger daughter is healthy and happily married, blessed that I have two other sons, daughters-in-law and a precious grandson, blessed that I am here 10 years after breast cancer and living life actively, blessed with wonderful friends and blessed to know that I have Jesus in my heart.

Remember, we all have a story to tell. Be a blessing to others.

Steel Magnolias and Men of Steel Meeting

The Steel Magnolias Breast Cancer Support Group, Inc. met on Tuesday February 25th in the private dining room of RMC. President Elaine Johns began the meeting at 5:00 p.m. by welcoming our guest speaker, Dr. Melissa Baird, Anniston Oncology, and our new members. Nancy Burnell, Chairman of the Welcoming Committee, presented our new members; Regina, Jackson, Ellen Simpson and Carrlotta Davis with a welcome gift. Each new member was given the opportunity to share their story and diagnosis with the group.

Chaplain Sherry Grinstead asked the blessing on the food, and President Elaine Johns invited Dr. Baird and our new members to prepare their plates first. All enjoyed the baked potato meal that was provided by RMC Cafeteria and the side dishes and desserts that were provided by the Steel Magnolias members. After dinner, Vice President Nancy Gillespie introduced Dr. Baird by providing information on her educational and professional background; as well as Nancy's own personal experiences with Dr. Baird as a physician.

Dr. Baird's presentation was on the BRACA1 and BRACA2 genes and how women with the mutation of these genes can be at an increased risk for developing breast and/or cervical cancer. Dr. Baird also informed the group that men with these mutations also have an increased risk of breast cancer, and both men and women who have harmful BRCA1 or BRCA2 mutations may be at risk for additional types of cancer. Dr. Baird explained that a harmful BRCA1 or BRCA2 mutation can be inherited from a person's mother or father, and that each child of a parent who carries a mutation in one of these genes has a 50 percent chance of inheriting the mutation. She explained that a person can be tested for the BRCA1 and BRCA2 mutations with a simple blood test; however, everyone does not need to be tested. Dr. Baird told the group that there is a Gail Model website where anyone can input their family history to determine their risk of having the mutated gene, and recommended that anyone with a risk factor of at least 10 percent be screened. After her presentation, Dr. Baird answered questions from members of the group. Following the question and answer session, Nancy Gillespie thanked Dr. Baird for speaking to our group and presented her with a beautiful plant.
